1. PROVISIONAL RESULT

Teodósia Maria Beatriz Cesário José	Social, Work and Organizational Psychology	Mozambique	Master's	Refused - After independent analysis of Essay 1 and Essay 2 by the members of the selection committee and during the committee meeting on May 25, 2023, both essays were found lacking due to: (a) lack of an understandable indication of how studies at PSTO can contribute with future professional activities of the candidate in home country; (b) lack of an original and minimal conceptual discussion on the interest variable, with a vague theoretical review and no broad mentions or citations linked with recent empiric production in social psychology from the research theme presented by the candidate; (c) lack of a clear theoretical and methodological alignment with the goals presented in the project, resulting in a level of theoretical analysis which is seemly unconnected with the scientific production on social psychology for the theme, besides a lack of connection with the proposed methodological strategies .
Arlindo Andre Pacote	Education	Mozambique	Doctoral	Refused - (a) lack of adequacy of the pre-project to the structure and field of Education; (b) little consistency in the presentation of the theme, the research problem, significance and goals, considering the field of Education; (c) lack of relevance of the presented literature review and theoretical foundations considering the field of Education; (d) lack of adequacy of the research methodology; e) little viability of the research proposal; and (f) lack of adequacy of the bibliographic references to the research object and the field of Education.
Jesús Gómez Jiménez	Social Anthropology	Spain	Doctoral	Refused - After reading the essays submitted by the candidate, the committee has concluded that, despite the theoretical scope - "Anthropology of Politics" - being a consolidated research topic at PPGAS-UnB, the candidate's proposal is not connected to the reflections developed by the PPGAS-UnB faculty, neither does it make an effort to critically and reflexively engage with the knowledge produced in the field in Brazil.

2. APPEALS

- 2.1. Requests for reconsideration and appeals will be accepted within the deadline set out in the schedule item 15 of this Call, and must be submitted in a standard form available at https://forms.office.com/r/2prjmVgBjT.
- 2.2. Reconsideration requests will be reviewed and judged by the Selection Committee which will provide a final decision. Only in the event of a **formal defect**, an appeal can be filed, which has no suspensive effect for the selection, with the International Affairs Office and the Chamber for Research and Graduate Studies (CPP) of the University of Brasília, in this order, in accordance with art. 60 of the General Regulations of the University of Brasília.
- 2.3. During the appeal phase, candidates will not be allowed to submit new documents.
- 2.4. Appeals to the final result can only be filed with the Graduate Program Collegium, the Council of the Academic Unit, and the Chamber for Research and Graduate Studies (CPP), in the event of a formal defect, within 10 (ten) business days after the publication of the Final Result, in accordance with art. 61 do Regimento Geral da Universidade de Brasília.
